Agreement

(Please complete before the first training session or class)

1. **Introduction** - Agreement dated _____ by and between **BOB BURRUD'S PET SERVICES, INC.** (hereinafter referred to as "Trainer") and (Hereinafter) referred to as "Client").
2. **Disclaimer** – Client understands and agrees that dog will learn only with repeated practice between Client and his/her pet. Trainer disclaims all warranties or guarantees, expressed or implied that the dog will learn proper obedience through this training service. Trainer is providing Client with instructions and training that have been successful with repeated practice and patience between pet owners and their pets. The primary responsibility for the dog's learning is on the Client as outlined.
3. **Release of Liability** - **BOB BURRUD'S PET SERVICES, INC.**, Bob Burrud, individually and his agents, principals and employees shall not be liable for any personal injury, property damage or any other damage to Client, Client's dog or Client's property, whether direct damage or consequential in nature. Client agrees to hold harmless Bob Burrud's Pet Services, Bob Burrud, individually and his agents, principals and employs for any loss, costs or damages, attorney's fees, court costs or other liability resulting from the dog training classes, whether resulting from negligence of the Client, Trainer, third parties or their animals.
4. **Entire Understanding** – This agreement contains the entire understanding between Client and Trainer and supersedes all previous agreements whether oral or in writing. This agreement may not be modified except in writing signed by both client and trainer.
5. **Governing Law** - This agreement shall be interpreted under the laws of the State of California.
6. **Attorney Fees** – If either party breaches this agreement and legal action is commenced, the prevailing party shall be entitled to his/her attorney fees and court cost.
